I appreciate your time on the phone this morning. As discussed, the points below were brought to my attention and I want to ensure the City of Inglewood and SCE are coordinating to meet electric infrastructure needs and timelines.

*Steve Ballmer, owners of the Clippers who is building the arena in Inglewood also announced this week that he is committed to the following as an agreement with CARB:

1) Installing 330 EV chargers in/within the Clippers Arena

- 2) Installing 1,000+ public EV chargers throughout the City of Inglewood
- 3) Two full size EV buses for the City of Inglewood
- 4) Adding 10 EVs to City's muni fleet
- 5) Planting of 1,000 trees

These chargers do not include those that are being installed by other private residential developers. It is estimated that Inglewood will get 3,000+ new housing units within the next 18 months to 2 years.
