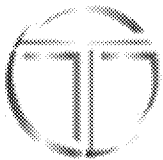

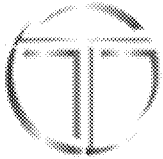

That would allow me to loop in others that are key. Please let me know; alternatively I can arrange for a conference call between myself and your team where I would represent Metro's overall comments.

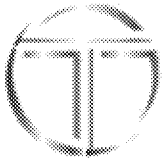

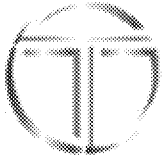

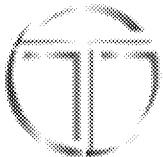
