<u>Please note the following regarding the extension of the public comment period of the Draft Environmental Impact Report for the Inglewood Basketball and Entertainment Center to March 24, 2020.</u>

On December 27, 2019, the City released the Draft Environmental Impact Report (EIR) for the Inglewood Basketball and Entertainment Center. As set forth in the notice of availability issued by the City on December 27, 2019, the initial deadline to submit comments on the Draft EIR was February 10, 2020.
