Murphy's Bowl (Proposed NBA Arena)

Please note the following regarding the extension of the public comment period of the Draft Environmental Impact Report for the Inglewood Basketball and Entertainment Center to March 24, 2020.

On December 27, 2019, the City released the Draft Environmental Impact Report (EIR) for the Inglewood Basketball and Entertainment Center. As set forth in the notice of availability issued by the City on December 27, 2019, the initial deadline to submit comments on the Draft EIR was February 10, 2020. On February 5, 2020, the City elected to extend the initial comment period by 30 days to March 10, 2020. On March 4, the City elected to extend the initial comment period by an additional 7 days to March 17, 2020. On March 13, 2020, the City elected to extend the initial comment period by an additional 7 days to March 24, 2020. The revised deadline to submit comments on the Draft EIR and technical appendices is March 24, 2020. Written comments on the Draft EIR and technical appendices must be received no later than 5:00 p.m., on March 24, 2020.
