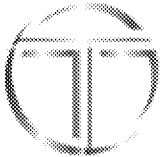

Hi.

I apologize for the confusion. I corresponded with someone from the front counter. Since I've already created a project number for this case to schedule the hearing, they said there was no need to submit the application through the CSS platform. Instead, you can simply email me or send a Dropbox link for the application and all related materials. The CSS is only if there is no preexisting number assigned to it (as if someone would submit something without prior notice). The only time access to CSS would be to make an online payment. The front counter planner will arrange for an invoice to be mailed/emailed to you for payment, and registration is required to make the payment online.

This isn't how we normally do things, as we usually ask to have someone come into the office to drop off paper applications and check, so this is the first aviation case to be submitted completely online.


