PEDESTRIAN BRIDGE AIRSPACE LEGAL DESCRIPTIONS

PEDESTRIAN BRIDGE AIRSPACE (PRAIRIE)

THAT PORTION OF SECTION 3, TOWNSHIP 3 SOUTH, RANGE 14 WEST, SAN BERNARDINO BASE AND MERIDIAN, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

AN AERIAL EASEMENT FOR PEDESTRIAN BRIDGE PURPOSES 28.00 FEET IN WIDTH OVER AND ABOVE THAT PORTION OF 101ST STREET AND PRAIRIE STREET AS SHOWN ON TRACT MAP NO. 211, RECORDED IN BOOK 15, PAGES 50 TO 51 OF MAPS, INCLUSIVE, AND THE LOCKHAVEN TRACT RECORDED IN BOOK 17, PAGE 87 OF MAPS, IN THE OFFICE THE COUNTY RECORDER OF LOS ANGELES COUNTY, CALIFORNIA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE CENTERLINE INTERSECTION OF SAID 101ST STREET AND PRAIRIE STREET; THENCE SOUTH 00°06'07" WEST ALONG THE CENTERLINE OF SAID PRAIRIE STREET 10.82 FEET TO THE POINT OF BEGINNING, SAID POINT BEING ON THE CENTERLINE OF SAID 28 FEET WIDE EASEMENT; THENCE NORTH 71°00'00":EAST ALONG SAID CENTERLINE 52.91 FEET MORE OR LESS TO THE EASTERLY RIGHT OF WAY LINE OF PRAIRIE STREET, 100 FEET WIDE; THENCE REVERSING COURSE SOUTH 71°00'00" WEST ALONG SAID CENTERLINE 105.82 FEET, MORE OR LESS, TO THE WESTERLY RIGHT OF WAY OF SAID PRAIRIE STREET. THE SIDELINES OF SAID EASEMENT TO BE EXTENDED OR SHORTENED TO TERMINATE AT THE RIGHT OF WAY LINES OF SAID PRAIRIE STREET AND 101ST STREET; THE BOTTOM PLANE OF THE VERTICAL SPACE CONTAINED WITHIN SAID EASEMENT SHALL BE 13.92 FEET ABOVE THE "0.00 LEVEL" CITED ON THE BRIDGE PLANS; AND THE TOP PLANE OF THE VERTICAL SPACE OF SAID EASEMENT BEING 15 FEET ABOVE THE BOTTOM PLANE.
