The proposed Inglewood Basketball and Entertainment Center (Clippers Arena) site is comprised of the southeast corner of Prairie and Century Boulevard's that includes the Church's Chicken restaurant. Future vendors have not been identified by the developer.

The Arena will have locations that will sell Clippers merchandise as well as other items.

The Inglewood Municipal Code requires the Arena to have handicap accessible parking spaces.
