

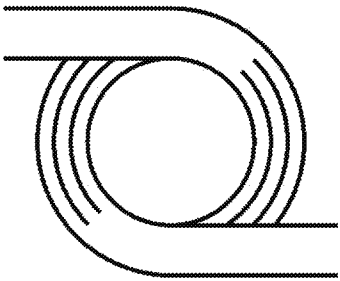

We requested record plans from Golden State Water Company for existing water mains in the project vicinity to be able to show the latest utility information on public works improvement plans.

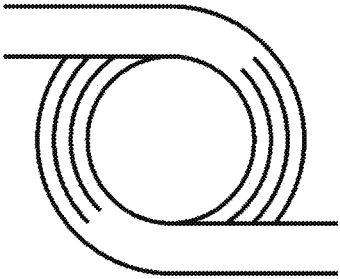
Golden State Water Company requested a letter of authorization from the City in order to provide as-built plans.
