### Mindy and Bettye,

We echo FAA's concerns regarding the sale of parcels acquired with FAA and LAWA noise grant funds for a basic purchase price of \$66,250,000.

LAWA reminds the City of their obligations in the Letters of Agreement (LOA) between LAWA and the City in acceptance of LAWA grant funds used to purchase the parcels under the Land Recycling Program. The City is obligated to comply with the conditions of all LOAs that state, "The proceeds of the disposition of the property acquired by Inglewood with the LAWA grant funds will be refunded to the LAWA, on a basis proportionate to the LAWA's share of the cost of acquisition of such land, or will be reinvested in an approved Part 150 project, pursuant to such instructions as the FAA will issue."

LAWA expects no less than 20% of the sale proceeds from this transaction at current fair market value be applied towards approved Part 150 projects (e.g., residential sound insulation) or returned to LAWA in compliance with the LOAs since LAWA funded at least 20% of the costs of the purchase of the parcels in the Program.

We look forward to discussing the details at the proposed meeting with FAA and City officials and will provide a follow up letter to this email.

Mindy & Bettye,

This is a response to the Hearing notice and request for a meeting.

We are still awaiting your team response to set up a meeting with Inglewood to discuss Close-out Documentation for the Property Acquisition program at Inglewood which could impact Inglewood's federal liability for the reuse of Noise Land. This is critical since Inglewood has not located the closeout documentation as indicated in the attached email.

We notice that the announcement indicates that DDA contemplates & may provide a Basic purchase price of **\$66,250,000**. The offered price containing Noise Land proceeds must be <u>current</u> Fair Market Value (FMV) and proceeds associated with federal noise land acquisition must be used for current/future airport sound installation or reinvestment in other airport development projects. See the order of Preference Applying Sale Proceeds of AIP Funded Land per 49 USC § 47107(c)(4) in Table 1.

We want to make sure the City understands the requirements and do not <u>incur liabilities</u> as result of not incorporating requirements in AIP Funded Land per 49 USC § 47107(c)(4).

We recommend discussions (Zoom/or other Video Meeting) as soon as possible with the Mayor and/or City of Inglewood Economic and Community Development Department.

Could you please reach out to your executive team and provide dates for a meeting.
