Good day Chief Duvally,

I am writing in follow-up to our meeting on February 6 at Inglewood City Hall with Chris Jackson and Jim Bailey regarding the proposed Clipper's NBA Arena. As discussed, the attached correspondence was received from the Fire Department, which included the following statement regarding the proposed arena:

"A Development of this scale has the potential to significantly impact service demands by increasing the call volume for incidents requiring fire department services (i.e., Fire, EMS, vehicular accidents, etc.) thereby placing a heavier burden on existing resources and potentially affecting response times in the area. If additional staffing, equipment, or facilities become necessary due to the substantial growth in the Project Area, funding would have to be negotiated between the City of Inglewood and the LACFD."

As you know we are currently preparing an environmental analysis of the proposed arena. For purposes of our environmental analysis, we request your clarification on the above text. Specifically, does LA County Fire anticipate that a new Fire Station will be needed in the Inglewood vicinity as a result of the Clippers Arena being constructed? This clarification is needed in order for us to complete our environmental analysis of the proposed arena. Your attention to this matter is appreciated. Please contact me if you have any questions.
