Hi Mike,

We have received all the counts for Friday and Saturday (various time periods) at most locations and are in the process of conducting preliminary QA/QC checks (flow, variation over time periods, etc.). We are scheduled to conduct the remaining additional intersection TMCs during the same days/time periods at the LA-County requested locations this weekend. We should have a complete picture of the "missing counts" by late next week. We have noticed lane closures at a few locations due to construction-related activities. Once we have all the data needed for your project collected and processed, we will let you know the overall picture.
