It's the new intersection called HP Casino Drive & Century Blvd. We haven't seen the new counts yet but guess that the north leg of Doty Avenue & Century Blvd. was closed when they were done, and that trips to/from the Casino were occurring at this new intersection. Can you arrange for new counts to be done at HP Casino Drive & Century Blvd. during the peak periods being analyzed for the Clippers Arena?

Hi Mike,

We have received all the counts for Friday and Saturday (various time periods) at most locations and are in the process of conducting preliminary QA/QC checks (flow, variation over time periods, etc.). We are scheduled to conduct the remaining additional intersection TMCs during the same days/time periods at the LA-County requested locations this weekend. We should have a complete picture of the "missing counts" by late next week. We have noticed lane closures at a few locations due to construction-related activities. Once we have all the data needed for your project collected and processed, we will let you know the overall picture. But, for the most part, we think that most of the locations that you had requested have been successfully completed and processed. The additional locations data collection status will be known, hopefully by the end of next week.
