I have no comments on the survey but wanted to share with the team, language that's currently in the zoning code and may be relevant for parking locations found in the City that are not standalone parking lots but instead are parking lots that provide code required parking for an adjacent business. We may need to amend the code language as the parking locations in the City are identified:

Section 12-42 (G)

(G) Off-Hour Parking for Major Event Patrons. Any business, located within one thousand five hundred feet of a major sports or entertainment facility that can accommodate at least ten thousand patrons, may permit those patrons to park for a fee upon the parking lot of the subject business, provided that:

(1) The normal business activities, for which the parking lot is required, shall have ceased at least one hour before the major sports or entertainment event commences; and

(2) The subject business has obtained current and proper permit(s), to charge a fee for parking, from the Committee on Permits and Licenses as provided in Chapter 8 of this Code.
