Hi Brian. Our response times during events at Staples and/or the convention center, do not increase. The reason is because I have a dedicated Entertainment Unit that works the Staples campus 7 days a week and handles the policing of all events there, and they also respond to calls for service on the campus.

As far as traffic control, that is handled by Staples Center. For very large, high profile events, Staples Center will hire off-duty LAPD officers to provide additional visible presence.

And how much do response times increase due to these large events at Staples Center?

What protocols/procedures/dispatch systems/traffic control do you have in place to handle these large-scale events at Staples Center?

I would like to use this information as a comparison for our analysis within the IBEC Draft EIR.
