



- Pedestrian Bridge(s)



Proposed Site Plan







CEQA Overview and EIR Process



- The California Environmental Quality Act (CEQA) applies to discretionary projects.
- The purpose is to inform decision-makers, agencies, organizations, and the public of the environment effects of a project
- Identifies potential effects on the environment
- Identifies ways to avoid or reduce potential significant effects through mitigation measures or alternatives
