There are a few people that left today without storing documents. I will see that is done tomorrow.

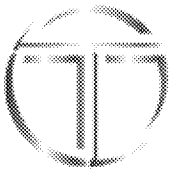

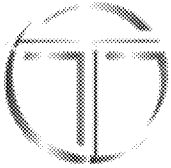
