#### Team,

Following feedback on the IBEC EIR schedule at last week's meeting, ESA revised the project schedule to further accelerate the overall timetable. To do that, we made substantial changes to how we deliver the Administrative Draft EIR, reduced how much time we allow for review of each submission of the EIR, and identified in-person working sessions to review each EIR submission and speed the internal review process. As a result, we made up 10 weeks in the overall schedule. This is Version 8.1 dated September 24, 2018.

While the overall schedule has been revised, this email focuses mainly on details surrounding the Administrative Draft EIR.

## Notes:

- We anticipate City/Applicant concurrent review of all administrative drafts.
- The schedule shows a split deliverable for the Administrative Draft EIR. We propose submitting three distinct rounds for concurrent City/Applicant review.
- Each round of review will consist of approximately one week to review an electronic version of the sections, followed by a 2-day in-person intensive war room meeting.
- Screencheck reviews will be shorter, but will also include in-person intensive war room meetings.
- The City will be responsible for reserving meeting space and providing electronic equipment such as a tv and computer hook-ups for the in-person war room sessions.
- Trifiletti will be responsible for assisting the City with meeting space coordination, equipment provision, and food/beverages during war room sessions.
- It is anticipated that each person who attends the war room session(s) will bring their own printed copies of sections (if desired). ESA will make real-time electronic edits to sections during the war room sessions.
