Hi Perla,

I left you a voicemail, but wanted to follow up with the group. Thanks for the files, but I'm not sure this is what we are looking for. Most of the files are .dwg files, which requires some conversion to make them readable. But the few .pdf files that are in the Westchester folder seem to indicate that these files are geotechnical files and architectural drawings that show information about foundation types, shearwalls, and piles.

We are looking more for site plans/drawing/architectural plans that show pedestrian staging areas (including width and length of sidewalks), location and number of bus/shuttle bays (or length of bus/shuttle curb space), location of vehicle parking areas and number of parking spaces, and information that generally shows passenger loading/waiting areas and vehicle loading/access/circulation areas. If I'm not mistaken, I thought Louis Atwell said the City has this information, or that Metro had it readily available.

In addition to the three stations you are investigating for the Crenshaw/LAX line (1. Downtown Inglewood, 2. Fairview Heights, 3. Westchester/Veterans), we also would like the same data for the 4. La Brea Station.

Please let me know if you have questions about the requested data.


Good morning,
