Meeting Minutes

A conference call was held on May 16, 2019 at 4:00 Pm with the above participants for the third consultation between the City of Inglewood, Lead Agency for Inglewood Basketball and Entertainment District (IBEC) and the Gabrielino Band of Mission Indians – Kizh Nation.

- Mindy Wilcox initiated the call by providing a recap of previous consultations the City has had with the Tribe and discussing how the project team has revised the mitigation language to incorporate comments provided by the tribe in the second consultation.
 - Language that states a Native American Monitor will be maintained and present during the excavation associated with the project
 - The Native American Monitor will coordinate with a trained archeologist. The tribal monitor will start full time with the possibly of reducing to part time inspection, or ceased entirely, if determined by both the Native American monitor and archeologist.
- Scope of Resources Discussion
 - Tribal Chair Andrew Salas requests mitigation measures include additional language that further defines the protocol for artifacts that are found during excavation or construction of the project.
 - ESA (Sara) stated that if a resource is determined to be historical or unique pursuant to CEQA, a data recovery or cultural resource plan will be implemented by an archeologist in consultation with a tribe monitor.
 - If artifacts are located, the Tribe requests the cultural resources are returned to the Tribe and not send to museums as these cultural resources play an important role in preserving their culture. Cultural resources also play an important role educating the general public about their culture.
 - The City of Inglewood and ESA agreed to revisit the mitigation measures proposed and potentially revise language.

- Next Steps

1. ESA to update mitigation measures to incorporate comments provided by tribe during the third consultation
2. City to approve changes to the mitigation measures
3. Call between the City and Tribal representatives to review final draft of the mitigation measures
4. City to send the finalized mitigation measures to the Tribe for final review and input
5. Once the Tribe concurs that the mitigation measures are finalized, the consultation process is over.
