The Inglewood Police Department employs 186 sworn personnel and 92 civilian personnel. The department consists of multiple resources, such as specially trained canine teams, directed enforcement units, scientific services investigators, bike teams, community affairs, fiscal services and recruitment.

The Department has an overall response time goal of 3 minutes for emergencies. Calls for service in the City of Inglewood are categorized by Priority 1 through 3 calls. Currently, the Department's average response time is 8 minutes and 7 seconds for emergencies, 20 minutes and 5 seconds for Priority 2 calls, 30 minutes and 9 seconds for Priority 3 calls.

- 6. Please provide a general overview of the City of Inglewood PD's emergency response system (i.e., dispatch system, standard procedures and protocols, etc.).**

The Inglewood Police Department provides 24-hour telephone service to the public for information and for routine or emergency assistance. The Department provides two-way radio capability providing continuous communication between the Communications Center and department members in the field. The police radio system is for official use only, to be used by dispatchers to communicate with department members in the field.

A call is considered an emergency when there is an immediate or potential threat to life or serious property damage, and the timely arrival of public safety assistance is of the utmost importance. A call is considered a non-emergency call when there is no immediate or potential threat to life or property.

- 7. Are there any specific Project design features, special police protection requirements, or mitigation required due to the specific attributes of the Proposed Project?**

The impact to police services in the city may be significant as a result of the proposed project.
