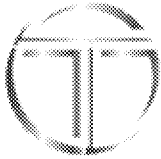

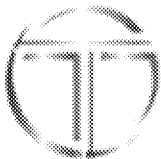

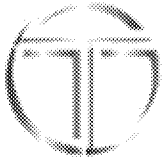

Don't feel bad. I asked her before I emailed you. 😊 She said that she thinks she won't have service. But email her anyway. Maybe she can work out something.

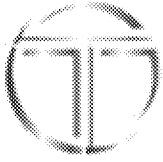
