Hello –

There are several important State regulations regarding solid waste, recycling, and organics recycling for the Clippers Arena to consider:

**AB 939** – Requires Citywide diversion of 50 percent of all solid waste through source reduction, recycling, and composting activities.

**AB 2176 Large Venue and Large Event Recycling Programs** – The law requires large venue and large event operators to plan for solid waste reduction, and upon request, report information regarding their waste reduction efforts to their local jurisdiction. Large event operators shall meet with recyclers and solid waste handlers to select appropriate waste diversion programs. On or before July 1 annually thereafter, each operator of a large venue or large event shall submit to the local agency, upon request by the local agency, written documentation of waste reduction, reuse, recycling, and diversion programs, if any, implemented at the large venue or large event, and the type and weight of materials diverted and disposed at that large venue or large event. **AB 341 Mandatory Commercial Recycling** – Requires all commercial businesses and public entities that generate 4 cubic yards or more of waste per week to have a recycling program in place. In addition, multi-family apartments with five or more units are also required to form a recycling program.

**AB 1826 Mandatory Organics Recycling** – Requires businesses that generate a specified amount of solid waste (trash, recycling and organics) per week to arrange for organics recycling services.

**SB 1383 Short-Lived Climate Pollutants** – Establishes targets to achieve a 50 percent reduction in the level of the statewide disposal of organic waste from the 2014 level by 2020 and a 75 percent reduction by 2025. Requires edible food generators to implement a food recovery/donation program. Organics waste collection services required for all residential and commercial generators. Recycling and Organics waste containers will need to be located where public refuse bins are located (e.g. cafeterias, park trashcans, etc.); therefore the arena will need to plan for adequate space for organics waste, recycling, and refuse containers in public areas and bin enclosures.

**CalGreen / Construction & Demolition (C&D) Debris Recovery Program** – Requires that at least 65% by weight of job site debris generated by most types of building project types be recycled, reused, or otherwise diverted from landfill disposal. This requirement applies to demolition projects and most new construction, as well as the majority of building additions or alterations. CalGreen requires submission of plans and reports with verifiable post-project documentation to demonstrate that at least 65% of the nonhazardous construction and demolition (C&D) debris generated on the job site are salvaged for reuse, recycled or otherwise diverted.

If needed, I can arrange a meeting to include the City's solid waste consultant, HF&H Consultant. They would be happy to meet with staff and/or the Arena's environmental division to discuss the State regulations in further detail. Please let me know.
