Good morning Lisa.

I'm writing to ask for your help with two information items, both from Metro. in each case, we can certainly contact Metro staff ourselves but I recall that you wanted to coordinate this. Either way is fine, but please advise on how we should proceed.

During the conference call on 11/5, and once prior to that, you said you have more detailed plans for the LRT stations on the Crenshaw/LAX Line that are near the IBEC site. Please forward those to us, as we believe they will be useful supplements to the plans that you circulated on 10/8. It's the Downtown Inglewood and Fairview Heights stations that are most relevant for our ongoing analysis of the proposed IBEC project.

I noticed that last Thursday's Metro Planning & Programming Committee agenda included the "Centinela Avenue Grade Separation Traffic Analysis" as well as staff reports and a Power Point presentation. We're reviewing that study now because it includes an analysis of special events in the area, including events at the IBEC, Forum and NFL stadium. The documented posted on-line do not include Appendices A through E for that study. Can you get those and forward them to us? If not, we'll contact Metro directly to obtain them.
