Thanks for setting up this call, Perla. I may not be able to join the dial at 1 pm tomorrow after all, but Mike definitely will be.

The information needed for all but 4 of these 17 related projects is straightforward, so we should be able to get through them quickly. If the answers are not know by the people on the call, then let's assign someone to go back to the local agencies for clarification, and to document that process.

The four that are unusual are LAX Northside and the 3 TOD Plans in Inglewood. Ordinarily we'd treat the 3 TOD plans as long-term plans that govern future development in those areas but not assume development within them - unless specific projects within them have applications on file now or are identified by staff as reasonably foreseeable. Also, I think that only the Fairview Heights TOD has an approved CEQA document but this should be clarified.

The Project Description chapter of the EIR for the LAX Northside Plan Update says that it is similar in that it sets up a framework to govern how "2,320,000 square feet of development [could occur], including a mix of employment, retail, restaurant, office, hotel, research and development, higher education, civic, airport support, recreation, and buffer uses."

The amount of growth, if any, in these four plan areas through 2024 should be thoughtfully considered and documented.
