Thanks. A few follow-up items:

- 1. At one time, you had these visual sims all as separate files. Do you still have them, and if so, can you please send to be via <a href="www.deliverit.esassoc.com">www.deliverit.esassoc.com</a>? We need them to create EIR graphics, and it would be easier to do from the separate files.
- 2. Concept View 3 shows the West Century Boulevard Pedestrian Bridge Variant. We intend to add a small label to the simulation to identify it as a Variant (as opposed to part of the proposed project). Since we have one simulation that includes the Variant, it would make sense to also update Concept View 8 to show the Alternate Prairie Access Variant. Alternatively, you could remove the West Century Boulevard Pedestrian Bridge Variant from View 3 and create two additional graphics which incorporate the two Variants.
- 3. We think Concept View 8 should be revised to remove the Let's Have a Cart Party building from the image. Our understanding is that building will not remain as part of the proposed project.
- 4. Concept View 4 should be revised to include Phase 1 development of the HPSP area, including the development in the SW portion of the site and the NFL Stadium (if it can be seen from the angle of the simulation).

While I'd like the separate files now, I understand that other revisions are likely a little ways out. Can you please add this to the to-do list?
