Hi Lisa.

Tom and I are available for a call this Wednesday (5/15) from 8 AM to 9 AM, 10 AM to 12 noon, and 1 PM to 3 PM. Let us know what time works best. The purpose of the call will be to follow up on the 4/24/ and 5/9 calls on this topic to finalize the assumptions on the TMOP that will be used in the analysis for the IBEC EIR.

Before then, as we discussed, it will be helpful to have a short memo from the TMOP team with the best assumptions to use in the IBEC study regarding the TNC loading and circulation patterns.

Below are some of our notes from the call we had last Thursday morning. If you have additional notes from that call, please circulate them.

- Which off-site parking locations we should be assuming for the stadium (and how many spaces at each) now that you have a tentative selection re the parking/shuttle operator.
- Direction is to follow table on page 9 of "SBHP grant proposal for the Inglewood Intermodal Transit Facility," assuming that 5200 Century Blvd (SW corner of La Cienega & Century) will be used, and to distribution demand for 8,000 Stadium parkers in proportion to the 6 sites shown.
- When parking lot plans may be submitted for additional parking spaces in the HP panhandle area. Direction is to assume only 9,000 spaces for Stadium or other event venue parkers will be available within the former HP site. Nothing more will be assumed in analysis of either Year 2024 or Year 2030.
- How/where Uber and Lyft will be handled.

TNC operators think the Stadium could draw 8% to 10% of attendees by TNC. Current TMOP shows much less. TMOP team to provide updated mode split analysis. Plan is likely to have two locations, one north of stadium and one to the south of it. North site is expected to be more heavily used and would on Kareem Court, which would be closed to non-TNC traffic. TMOP team to draft brief memo on TNC location siting, and assumptions on direction of travel on Kareem Court (2-way, SB, or NB?). Also need confirmation that south TNC site will be in Phase 1 development area as shown on page 165 of Draft TMOP dated March 2019. Also need confirmation that TNC loading will not be at HP Casino.

Are bus-only lanes and/or reversible lanes going to be a part of the TMOP (did not see any mention of those).

Cannot assume as part of EIR analysis of Stadium event. May be considered as potential mitigation for IBEC impacts, but not for Stadium impacts.

- Will the TMOP be proposing locations for traffic control officers?

 Did not discuss this on 4/24 or 5/9 call. Need input on this question from TMOP team.
- Page 169 in the draft TMOP purports to show employee remote parking shuttle circulation but it does not. What are the proposed plans for stadium employee parking?

Stadium will need 6,000 employees for a sold-out event. Parking arrangements are uncertain but may include Morningside HS. Seeking confirmation by the stadium planners on reasonable assumptions for employee parking.
