Hi Lisa,

I spoke to my counterparts at LA County Fire to see if they had any documentation on hospital access plans during event emergencies. Unfortunately, they do not have anything in writing just like us at the PD. Their standard transportation route for LA County Fire from the Forum to Centinela Hospital is northbound Prairie Ave to westbound Arbor Vitae St to southbound Myrtle Avenue. That is for basic first aid treatment and if the emergency required a trauma hospital then they would transport to Ronald Reagan UCLA Medical Center and their route would be westbound Manchester Bl to the northbound 405 fwy from the Forum. If the freeway is to congested then they would use La Cienega Blvd as an alternative route and go northbound all the way to the hospital. The dividing line is Arbor Vitae St in our city to determine which trauma center that LA County Fire will transport to. All trauma related injuries south of Arbor Vitae St. would be transported to Harbor UCLA Medical Center in Torrance and any trauma related injuries north of Arbor Vitae St. will go to Ronald Reagan UCLA Medical Center. All basic first aid related injuries in our city would go to Centinela Hospital. I hope this helps and if you need to speak with LA County Fire then I will put you in contact with them.
