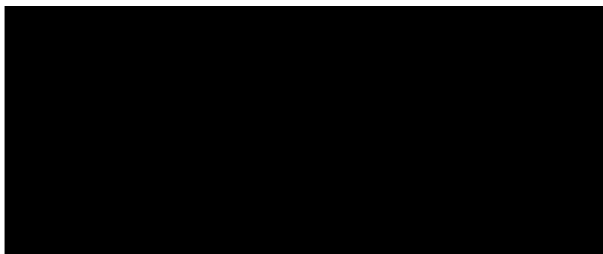
The agenda has been previously set for a detailed review of the Summary. We will evaluate the agenda tomorrow, and revise accordingly.
