Hi Peter,

As we are working through our NFL game concurrent event scenario for the IBEC EIR, we want to be as consistent as logically possible with the NFL TMOP team. With that in mind, can you provide the mode split numbers (transit, coach/charter buses, private vehicles, TNCs, etc.) that the TMOP team is using? We recognize these numbers may change, but as our schedule is so tight, we'd like to start with the number they are using now. Right now we only have the numbers from the Iteris report, which appear to be the same as the LLG memo from several years ago.

I'm also attaching additional count data that we've taken as part of the IBEC project:

- * Counts at 25 intersections on weekdays and weekends from November 2018, which will be used for our pre- and post-event analysis
- * Counts at 9 intersections on weekdays and weekends from December 2018, which will be used to estimate the traffic assignment related to The Forum. Counts were taken on two dates with concerts (12/13 and 12/17) and one date without a concert (12/10)
