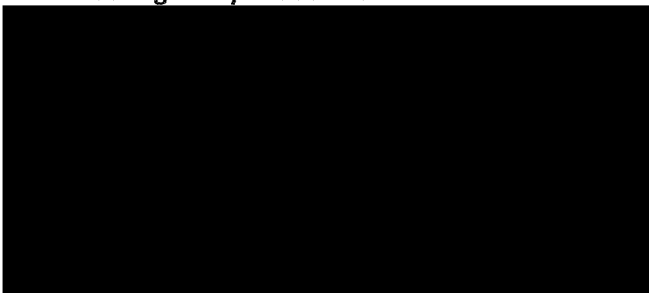
On Tuesday we will set a schedule for this day as not everyone (other than Heidi) needs to be in the meeting all day.

Also, we are showing a start of 8:30 so that we can start promptly at 9:00am. ☺

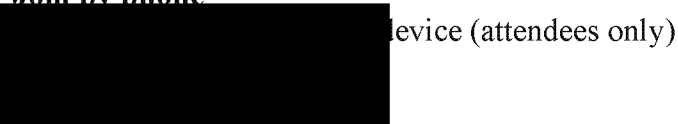
