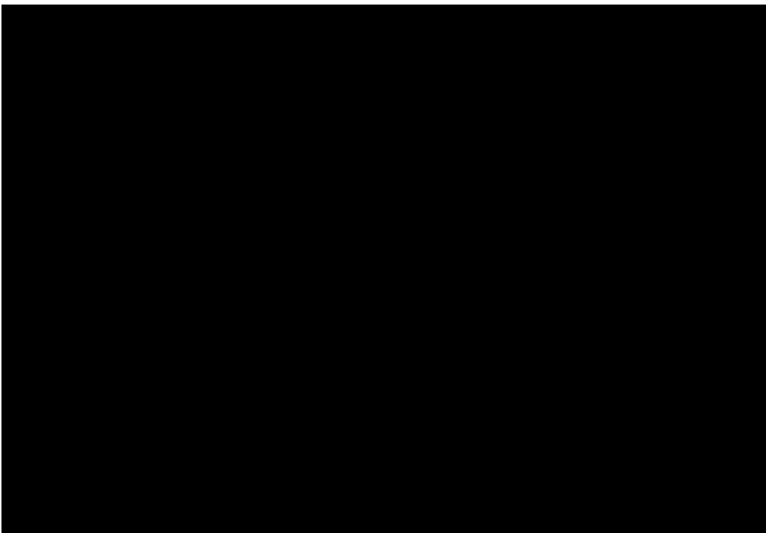
On Tuesday we will set a schedule for this day as not everyone (other than Heidi) needs to be in the meeting all day.
