Hi Brian,

We have confirmed with building that they have the following permit options:

1. Demolition Permit
2. Grading/Excavation Permit
3. Building Permit includes:
 - a. Fire Sprinklers
 - b. Retaining Walls
 - c. Concrete/Stucco work
 - d. Roofing
 - e. Windows
 - f. All Exterior Work
4. Electrical Permit
5. HVAC & Heating Permit
6. Plumbing Permit

7. Sewer Permit

Based on the above, I would suggest that we refer to the initial permit as one of the following:

- 'any Demolition or Construction Permits'
- 'any Building Safety Division permits'
- 'Construction Permits' (and in a footnote define Construction Permits to include all of the above permits)
