	independent audit firm, is here. But before he presents to you, I'd like to just take a brief moment to thank the Mayor and Council for your support over these years and just to let you know this year we did it was a very good job done by the accounting staff. All of our audit reports were completed before the due dates and I just wanted to give you a little background. Over the last several years, the group, the accounting department is in the back. I just wanted to acknowledge them. They have helped as a team to address over 63 audit findings. We found this year we only had four. None of them were major significant financial impacts, they were more compliance. And I just wanted to take the time to acknowledge the staff.
James Butts	Thank you.
Sharon Koike	You're welcome.
James Butts	Thank you. And we've come a long ways from when I came to this Council. We were really behind on our audits and now we're all caught up and I want to compliment the staff as well. Thank you. Receive and file the City of Inglewood's Basic Financial Statements. That was
Sharon Koike	Do you have any questions for the auditor? He's here.
James Butts	That was the presentation. But if you guys have any questions for the auditors.
Ralph Franklin	I do have a comment, Mayor.

Ralph Franklin	So when I was reading some of the items for cure and corrections, there was an area raised regarding the lack of procedures and controls, particularly being done in a timely manner. Now that has brought to our light have we put procedures in order to rectify that?
Sharon Koike	We have put many procedures in place. In fact, as I mentioned before, this year we have four audit findings. Three of them were basic compliance findings with reporting with some of our grants. All of the findings in the past that had to do with internal controls and lack of procedures or timely reconciliations have all been resolved.
Ralph Franklin	Thank you. Because I was concerned when you're dealing with federal dollars, particularly CDBG, they have a mandate you must meet these certain requirements.
Sharon Koike	Right.
Ralph Franklin	And I'm glad that we're now have an internal procedures and processes so that will not become an issue.
Sharon Koike	That's correct.
Ralph Franklin	Thank you, Mayor.
James Butts	Comment by District Two.
Alex Padilla	This report, I mean, you can tell by reading it how involved it was and how attention to detail. You know, they say the devil's in the details and so you guys really dug down and dug deep. And it was just good to see in those areas that they found that we need to be able to make some adjustments that we've already started moving in that direction to make those adjustments and working through the City Manager's office and our CFO, Mr. Esparza, to get that done. So thank you for that. Thank you for putting together a great

	report. And it's just really good to know that we're in better shape that we were a few years ago and we continue to head in the right direction. So thank you.

Wanda Brown	Just a brief comment regarding according to the Federal Reserve Bank of New York. Household debts increased by \$63 billion to \$13.21 trillion in the first quarter of 2018. And just to give you the balances of the debt. The mortgage debt is now at \$8.94 trillion. Student loans at \$1.41 trillion. Auto loans, \$1.23 trillion. Credit card, \$815 billion. Home equity credit line, \$436 billion. Total of \$13.21 trillion. The delinquency rate on debt balances, 90 days or more for mortgage improved to 1.2%. Student loans declined to 10.7%. Auto loans edged higher to 4.3%. And credit cards rose 8.0 with a Fed action to increase the Fed rate by 25 basis points now up to 2%. Major banks reacted immediately by increasing the prime lending rate to 5%. And with two more potential rate hikes through the end of the year, loans will become more expensive and money will continue to be drained from the system. That's just a household update. That concludes my comments.

So, I would think that we would have to have a forensic audit of the Inglewood finances.
